



Nifty futures closed at 14339 on a negative note with 2.75% decrease in open interest indicating Long Unwinding.


Nifty Futures closed at a discount of 3 points compared to previous day discount of 3 points.


BankNifty closed at 31710 on a negative note with 4.99 % decrease in open interest indicating Long Unwinding.

FII's were **Sellers** in **Index Futures** to the tune of **233** crores and were **Buyers** in **Index Options** to the tune of **310** crores, **Buyers** in the Stock Futures to the tune of **1297** crores. **Net Buyers** in derivative segment to the tune of **1524** crores.

India VIX index is at 22.69 v/s 23.02.Nifty ATM call option IV is currently 20.7 whereas Nifty ATM put option IV is quoting at 25.24

Index options PCR is at 1.27 v/s 1.27 & F&O Total PCR is at 0.89.

Among stock futures Long Build up are **CADILAHC**, **AMARAHBAT**, **AARTIIND & PVR** may remain strong in coming session.

Stock which witnessed Short Build up are **BRITANNIA**, **TVSMOTOR**, **L&TFH** & **M&M** may remain weak in coming session.

Nifty Put options OI distribution shows that 14000 has highest OI concentration followed by 13500 & 14200 which may act as support for current expiry.

Nifty Call strike 15000 followed by 14800 witnessed significant OI concentration and may act as resistance for current expiry.
