



Nifty futures closed at 14932 on a positive note with 28.81% increase in open interest indicating Long Build Up.


Nifty Futures closed at a premium of 937 points compared to previous day premium of 43 points.


BankNifty closed at 33807 on a negative note with 28.77 % increase in open interest indicating Short Build Up.

BankNifty Futures closed at a premium of 93 points compared to the previous day premium of 118 points.

FII's were **Sellers** in **Index Futures** to the tune of **648** crores and were **Buyers** in **Index Options** to the tune of **2481** crores, **Buyers** in the Stock Futures to the tune of **481** crores. **Net Buyers** in derivative segment to the tune of **3461** crores.

India VIX index is at 23.31 v/s 22.58.Nifty ATM call option IV is currently 19.38 whereas Nifty ATM put option IV is quoting at 24.80





Index options PCR is at 1.43 v/s 1.57 & F&O Total PCR is at 0.95.

Among stock futures Long Build up are **RAMCOCEM**, **TECHM**, **TONRTPOWER & HINDALCO** may remain strong in coming session.

Stock which witnessed Short Build up are AUBANK, GUJGAS, CIPLA & NAUKRI may remain weak in coming session.

Nifty Put options OI distribution shows that 14000 has highest OI concentration followed by 14500 & 15000 which may act as support for current expiry.

Nifty Call strike 15000 followed by 15500 witnessed significant OI concentration and may act as resistance for current expiry.
