



HIGHLIGHTS:

Nifty futures closed at 14752 on a negative note with 1.96% increase in open interest indicating Short Build Up.

Nifty Futures closed at a premium of 62 points compared to previous day premium of 68 points.

BankNifty closed at 33478 on a negative note with 3.87% increase in open interest indicating Short Build Up.

BankNifty Futures closed at a premium of 175 points compared to the previous day premium of 172 points.

FII's were **Sellers** in **Index Futures** to the tune of **2449** crores and were **Buyers** in **Index Options** to the tune of **2523** crores, **Sellers** in the Stock Futures to the tune of **636 crores**. **Net Sellers** in derivative segment to the tune of **593 crores**.

India VIX index is at 20.65 v/s 20.65.Nifty ATM call option IV is currently 19.15 whereas Nifty ATM put option IV is quoting at 22.16

Index options PCR is at 1.10 v/s 1.32 & F&O Total PCR is at 1.01.

Among stock futures Long Build up are LALPATHLAB, IDEA, CUMMINSIND & BATAINDIA may remain strong in coming session.

Stock which witnessed Short Build up are **IDFCFIRSTBK**, **PEL**, **HDFCBANK** & **HERMOTOCOP** may remain weak in coming session.

Nifty Put options OI distribution shows that 14000 has highest OI concentration followed by 14500 & 14700 which may act as support for current expiry.

Nifty Call strike 15000 followed by 15500 witnessed significant OI concentration and may act as resistance for current expiry.
