Precious metals

Gold fell on Monday as an uptick in U.S. Treasury yields dimmed bullion's appeal, while investors awaited key U.S. inflation and retail sales data for cues on economic health. Spot gold was 0.6% down at \$1,733.40 an ounce by 10:26 a.m. EDT (1426 GMT). U.S. gold futures eased 0.6% to \$1,734.20.

NYMEX Oil

Oil was up Tuesday morning in Asia, with investors continuing to assess the impact of an uneven economic recovery from COVID-19 on fuel demand alongside a potential increase in supply. Brent oil futures were up 0.24% to \$63.34 by 9:50 PM ET (1:50 AM GMT) and WTI futures edged up 0.17% to \$59.80. India, the world's third-largest oil importer, continues to see record numbers of COVID-19 cases and other countries remain under restrictive measures as the number of cases rises.

Base Metals

Copper prices slipped on Monday on worries that top metals consumer China wants to put a lid on surging commodity prices to head off potential inflation. Concern about faltering demand and rising copper inventories also weighed on the market. Benchmark copper on the London Metal Exchange (LME) had fallen 0.9% to \$8,845 a tonne by 1600 GMT. Copper has gained about 30% over the past five months, having touched a 9-1/2 year peak of \$9,617 in late February.
