Technical outlook

MCX Gold June futures technical chart has taken the formation of “Megaphone chart” pattern in 4hr time frame. Last few sessions ended up in sideways mode along with some corrections inside the channel. Based on the current price action, market is expected to continue on bullish momentum once the same breaks above the key resistance level holding near 45000. The

upside rally could possibly test up to 45300-45600 levels in the upcoming sessions. An alternative scenario indicates that if the market struggles to break the resistance level, then it might retest the same and revise the trend to bearish/sideways mode once again. Key support holds near 44700. A slide to 44400-44100 is also a possibility if the price makes or break below the current support level.
