



HIGHLIGHTS:

Nifty futures closed at 14855 on a positive note with 16.64% decrease in open interest indicating Short Covering.

Nifty Futures closed at a discount of 9 points compared to previous day discount of 8 points.

BankNifty closed at 33696 on a positive note with 28.91 % decrease in open interest indicating Short Covering.

BankNifty Futures closed at a discount of 27 points compared to the previous day premium of 7 points.

FII's were **Buyers** in **Index Futures** to the tune of **167** crores and were **Sellers** in **Index Options** to the tune of **1617** crores, **Buyers** in the Stock Futures to the tune of **1368 crores**. **Net Sellers** in derivative segment to the tune of **49 c**rores.

India VIX index is at 22.58 v/s 23.08.Nifty ATM call option IV is currently 17.84 whereas Nifty ATM put option IV is quoting at 25.75

Index options PCR is at 1.57 v/s 1.51 & F&O Total PCR is at 0.96.

Among stock futures Long Build up are **TVSMOTOR**, **SRTRANSIFN**, **CUB & HINDUNILVR** may remain strong in coming session.

Stock which witnessed Short Build up are **BIOCON**, **GMRINFRA**, **HDFCLIFE** & **NESTLEIND may** remain weak in coming session.

Nifty Put options OI distribution shows that 14000 has highest OI concentration followed by 14500 & 14600 which may act as support for current expiry.

Nifty Call strike 15000 followed by 15100 witnessed significant OI concentration and may act as resistance for current expiry.
