



HIGHLIGHTS:

Nifty futures closed at 15185 on a positive note with 1.22% increase in open interest indicating Long Build Up.


Nifty Futures closed at a premium of 12 points compared to previous day premium of 13 points.

BankNifty closed at 35809 on a negative note with 4.34% increase in open interest indicating Short Build Up.

BankNifty Futures closed at a premium of 57 points compared to the previous day premium of 92 points.

FII's were **Buyers** in **Index Futures** to the tune of **2** crores and were **Buyers** in **Index Options** to the tune of **2891** crores, **Sellers** in the Stock Futures to the tune of **285 crores**. **Net Buyers** in derivative segment to the tune of **2484 c**rores.

India VIX index is at 23.05 v/s 23.88.Nifty ATM call option IV is currently 16.62 whereas Nifty ATM put option IV is quoting at 19.39



Index options PCR is at 1.36 v/s 1.30 & F&O Total PCR is at 1.08.

Among stock futures Long Build up are **HINDALCO**, **M&MFIN**, **MGL & IDEA** may remain strong in coming session.

Stock which witnessed Short Build up are **BATAINDIA**, **BANKBARODA**, **ITC** & **HDFCAMC** may remain weak in coming session.

Nifty Put options OI distribution shows that 14500 has highest OI concentration followed by 15000 & 14200 which may act as support for current expiry.

Nifty Call strike 16000 followed by 15500 witnessed significant OI concentration and may act as resistance for current expiry.
