### **Observation:**

- >>> The attached weekly timeframe chart of EIH Ltd indicates a sustainable upside bounce, which started from last week.
- >>> We observe a larger degree of positive sequential movement like higher highs and higher lows, which is unfolding over the last few months.
- >>> The last weeks swing low of Rs 90.10 could be considered as a new higher bottom of the sequence. Hence, one may expect further upside in the near term.
- >>> Weekly 14 period RSI has placed around upper 60 levels. As per its formulation, RSI moving above 60 levels could mean further strengthening of upside momentum in the stock price.
- >>> The overall chart pattern of EIH Ltd indicate long trading opportunity. One may look to create a positional long as per the levels mentioned above.
