OUTLOOK - USDINR

Rupee opened strong at 72.92, 4 paise up from wednesday's close of 72.96 and closed flat at 72.96, to remain unchanged in effect from yesterday's close. Rupee had gained as far as the intraday high of 72.90 and intraday low was seen at 72.96. The dollar index which compares the strength of the dollar against 6 major currencies gained 0.28% and closed at 91.42. Brent crude futures rose a further 0.55% to close at \$58.78/barrel. USDINR near futures are at 73.1500 with the next support seen at 73.0600 and next resistance seen at 73.2025 ahead of market opening on friday.
