## Indiabulls Housing Finance Daily Chart



### Observations:

- After correcting from a high of 251 touched in early January 2021, Indiabulls Housing Finance found support around the 187 levels in early February 2021.
- As this is close to the 200 day SMA, it implies it is a strong support area. The stock then bounced back smartly and made higher tops and higher bottoms in the process.
- Yesterday, the stock broke out of the 210-230 range on the back of above average volumes. This indicates that there has been significant accumulation happening in this counter.
- Technical indicators are giving positive signals as the stock is trading above the 20-day and 50-day SMA and momentum indicators like the 14-day RSI are in rising mode and not overbought.
- With the technical set up looking attractive on all major timeframes, we expect the stock to gradually move higher in the coming weeks.
- Our entry levels with stop loss and targets have been mentioned above.
