Observation:

- >>> The attached weekly timeframe chart of Edelweiss Financial Services Ltd indicate a sharp upside bounce since last week.
- >>> The down trend of the last two months (Dec-20 to Jan 21) has been completed and the stock price seems to have formed an important bottom reversal at Rs 61.20 in the week before last. This is positive indication.
- >>> The recent bottom reversal has occurred at the intermediate trend line (connected from previous two bottoms) support of around Rs 61.50 in the last week.
- We observe a larger degree of positive chart pattern like higher highs and higher lows. The recent swing low of Rs 61.20 could be considered as a new higher bottom of the sequence. One may expect further upside in the near term.
- >>> The overall chart pattern of EDELWEISS indicate long trading opportunity. One may look to create a positional long as per the levels mentioned above.
