OUTLOOK - USDINR

Indian Currency market was closed on friday due to Chatrapati Shivaji Maharaj jayanti. Rupee opened flat at 72.76, from the previous close of 72.75 against the US dollar and finally closed high at 72.65, up 10 paise on thursday. USDINR had gained as far as the intraday high of 72.65 and fell to an intraday low of 72.78. The dollar index which compares the strength of the dollar against 6 major currencies fell 0.25% and closed at 90.36. Brent crude futures was down by 1.4% to trade at \$62.67/barrel. USDINR near futures are at 72.6300 with the next support seen at 72.5475 and next resistance seen at 72.7800 ahead of market opening today.
