



Nifty futures closed at 13844 on a negative note with 42.60% increase in open interest indicating Short Build Up

Nifty Futures closed at a premium of 27 points compared to previous day premium of 53 points

BankNifty closed at 30365 on a negative note with 58.30% increase in open interest indicating Short Build Up.

BankNifty Futures closed at a premium of 6 points compared to the previous day premium of 99 points.

FII's were **Sellers** in **Index Futures** to the tune of **1389** crores and were **Buyers** in **Index Options** to the tune of **4746** crores, **Buyers** in the Stock Futures to the tune of **920 crores**. **Net Buyers** in derivative segment to the tune of **5091 crores**.

India VIX index is at 24.29 v/s 24.39.Nifty ATM call option IV is currently 21.74 whereas Nifty ATM put option IV is quoting at 26.71

Index options PCR is at 1.34 v/s 0.89 & F&O Total PCR is at 0.98.

Among stock futures Long Build up are **AXISBANK**, **NMDC**, **MARICO & SHREECEM** may remain strong in coming session

Stock which witnessed Short Build up are PNB, BANKBARODA, NATIONALUM & MARUTI may remain weak in coming session.

Nifty Put options OI distribution shows that 14000 has highest OI concentration followed by 13000 & 13500 which may act as support for current expiry.

Nifty Call strike 14500 followed by 14000 witnessed significant OI concentration and may act as resistance for current expiry.
