Analysts and traders have downgraded their forecasts for gold but still expect prices to recover from current levels and many see it achieving record highs this year, a Reuters poll showed on Wednesday. Traditionally seen as a safe place to store wealth, gold surged to a record level of \$2,072.50 an ounce last summer as the coronavirus swept the globe.

NYMEX Oil

Oil prices were little changed on Wednesday, despite a massive drawdown in U.S. crude inventories, as ongoing concerns about the coronavirus pandemic tempered buying interest. U.S. crude oil stocks dropped by nearly 10 million barrels last week to their lowest levels since March, surprising the market, which was looking for a modest increase in stocks.

Base Metals

Copper prices edged down on Tuesday, hit by uncertainties about the outcome of a \$1.9 trillion U.S. stimulus package proposed by new President Joe Biden, which is expected to boost demand for metals. Three-month copper on the London Metal Exchange fell 0.6% to \$7,925.50 a tonne by 0730 GMT, while the most-traded March copper contract on the Shanghai Futures Exchange ended down 0.6% to 58,470 yuan (\$9,030.53) a tonne.

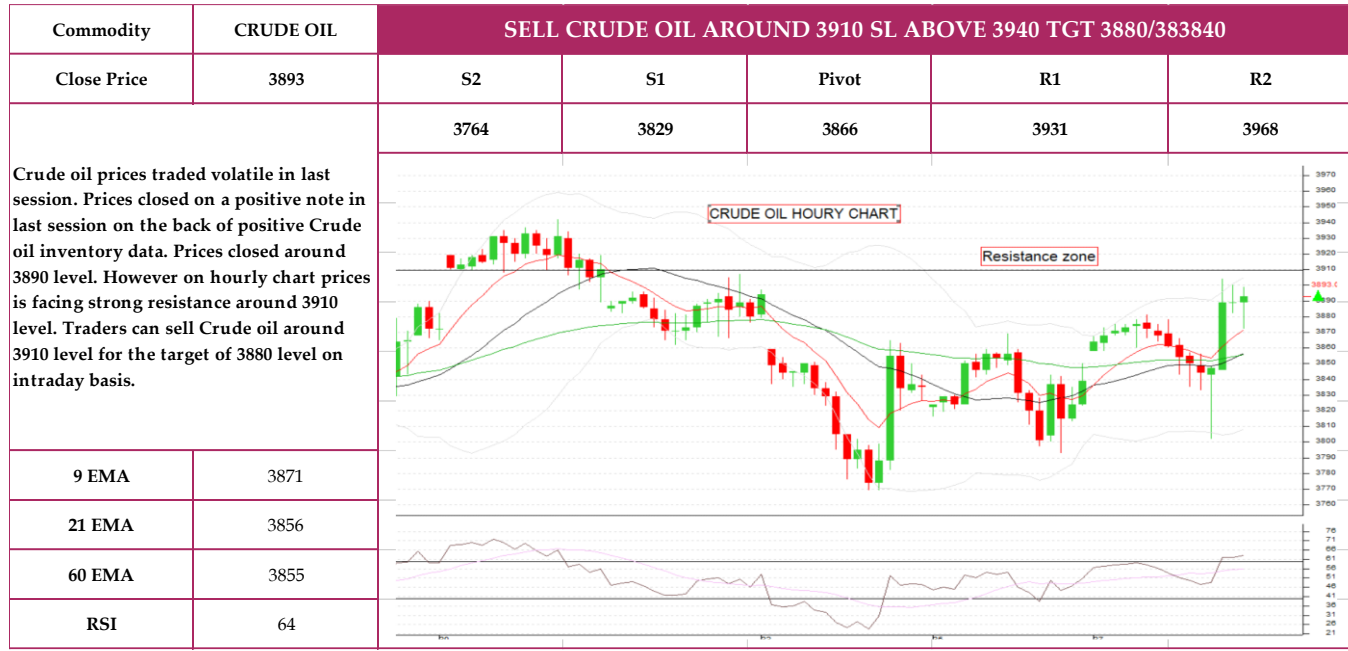
