



## **HIGHLIGHTS:**

Nifty futures closed at 15618 on a positive note with 1.37% increase in open interest indicating Long Build Up.


Nifty Futures closed at a premium of 43 points compared to previous day discount of 28 points.


BankNifty closed at 35454 on a negative note with 0.45 % decrease in open interest indicating Short Build Up.

BankNifty Futures closed at a discount of 149 points compared to the previous day discount of 104 points.

FII's were **Buyers** in **Index Futures** to the tune of **414** crores and were **Sellers** in **Index Options** to the tune of **1874** crores, **Buyers** in the Stock Futures to the tune of **215 crores**. **Net Sellers** in derivative segment to the tune of **1559 crores**.

India VIX index is at 17.39 v/s 16.89.Nifty ATM call option IV is currently 12.82 whereas Nifty ATM put option IV is quoting at 16.02





Index options PCR is at 1.32 v/s 1.51 & F&O Total PCR is at 0.99.

Among stock futures Long Build up are **ALKEM**, **AARTIIND**, **LICHSGFIN** & **MINDTREE** may remain strong in coming session.

Stock which witnessed Short Build up are **ASHOKLEY**, **CUB**, **SAIL** & **BHEL** may remain weak in coming session.

Nifty Put options OI distribution shows that 15000 has highest OI concentration followed by 14800 & 15200 which may act as support for current expiry.

Nifty Call strike 16000 followed by 15500 witnessed significant OI concentration and may act as resistance for current expiry.
