



## HIGHLIGHTS:

Nifty futures closed at 15769 on a negative note with 1.13% increase in open interest indicating Short Build Up.

Nifty Futures closed at a discount of 5 points compared to previous day premium of 3 points.


BankNifty closed at 35265 on a negative note with 1.06 % increase in open interest indicating Short Build Up.

BankNifty Futures closed at a premium of 2 points compared to the previous day discount of 38 points.

FII's were **Sellers** in **Index Futures** to the tune of **67** crores and were **Buyers** in **Index Options** to the tune of **858** crores, **Sellers** in the Stock Futures to the tune of **524 crores**. **Net Buyers** in derivative segment to the tune of **46 c**rores.

India VIX index is at 15.10 v/s 15.57.Nifty ATM call option IV is currently 11.52 whereas Nifty ATM put option IV is quoting at 15.01

## Nifty Options - Change in OI



Index options PCR is at 1.30 v/s 1.41 & F&O Total PCR is at 0.93.

Among stock futures Long Build up are **PFIZER**, **NAVINFLUOR**, **TORNTPOWER & UBL** may remain strong in coming session.

Stock which witnessed Short Build up are **BATAINDIA**, **CUB**, **MPHASIS** & **NATIONALALUM** may remain weak in coming session.

Nifty Put options OI distribution shows that 15000 has highest OI concentration followed by 15500 & 15200 which may act as support for current expiry.

Nifty Call strike 16000 followed by 16200 witnessed significant OI concentration and may act as resistance for current expiry.
