Technical outlook

Gold Aug MCX futures technical chart has taken the "Ascending formation of broadening wedge" pattern in 4hr time frame. Last few sessions ended up in sideways mode along with corrections inside the channel. Based on the current

price action, market is expected to continue on bullish momentum once the same breaks above the key resistance level holding near 48600. The upside rally could possibly test up to 48900-49200 levels in the upcoming sessions. An alternative scenario indicates that if the market struggles to break the resistance level, then it might retest the same and revise the trend to bearish/sideways mode once again. Key support holds near 48300. A slide to 48000-47700 is also a possibility if the price makes or break below the current support level.
