- »» The attached daily timeframe chart of West coast paper which is in uptrend from last several sessions.
- »» We observe a formation of bullish pattern on daily and weekly time frame.
- »» The stock is continuously trading above 21 EMA from last 8 sessions and filled the down gap which was created on 12th April suggesting bullishness for the stock.
- »» Momentum oscillators like RSI and MACD are giving bullish indication suggesting bullish movement for the stock for few more weeks.
- »» The overall chart pattern of Westcoast Paper indicates long trading opportunity. One may look to create positional long as per the levels mentioned above.
