### **Observation:**

- >>> The attached daily timeframe chart of Huhtamaki India Ltd indicate a larger consolidation movement over the last few months.
- >>> Technically, this pattern indicates a formation of accumulation type of pattern. Currently the stock price is making an attempt to stage upside breakout of the consolidation at Rs 298-300 levels.
- >>> A sustainable move above this area could open a sharp upside momentum in the stock price ahead.
- Daily 14 period RSI is around 60 and is expected to turn up from here. Its move above 60 could mean further strengthening of upside momentum.
- >>> The overall chart pattern of HUHTAMAKI indicate long trading opportunity. One may look to create positional long as per the levels mentioned above.
