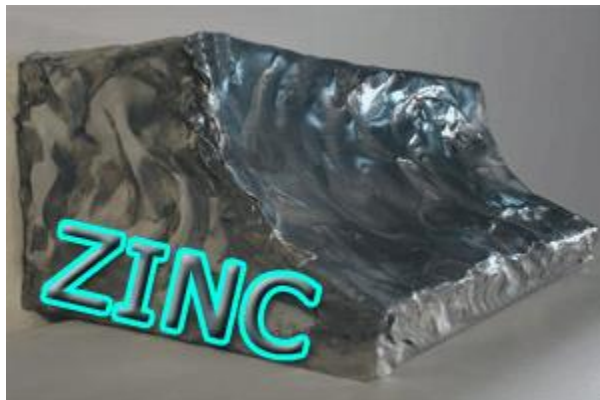

Technical outlook

Zinc June future 4hr Chart has formed "Megaphone chart" pattern. The last few sessions ended up sideways along with some corrections inside the channel. The market is expected to continue on the bullish term based on the current price action, once the same breaks above the current key resistance holding near 238.

The upside rally could be testing all the way up to 239.50-241 levels in the upcoming sessions. Alternatively, if the market struggles to break the resistance level, then it might retest the same and revise the trend to bearish/sideways. Key support holds at 235. A slide to 233.50 is also a possibility if the price makes or break below the current support level.
