Technical outlook

MCX Silver May futures technical chart has taken the formation of "Falling channel" pattern in 4hr time frame. Last few sessions ended up in sideways mode along with some corrections inside the channel. The market is expected to continue on bearish momentum based on the current price action, once the same break below the key support level holding near 64000. The downside rally could be extending all the way up to 63200-62400 levels in the upcoming sessions. An alternative scenario indicates that if the market struggles to break the support level, then it might retest the same and revise the trend to bullish/sideways mode once again. Key resistance holds near 64800. A slide to 65600-66400 is also a possibility if the price makes or break above the current resistance level.

The downside rally could be extending all the way up to 63200-62400 levels in the upcoming sessions. An alternative scenario indicates that if the market struggles to break the support level, then it might retest the same and revise the trend to bullish/sideways mode once again. Key resistance holds near 64800. A slide to 65600-66400 is also a possibility if the price makes or break above the current resistance level.
