



Nifty futures closed at 14609 on a positive note with 2.13% increase in open interest indicating Long Build Up.


Nifty Futures closed at a premium of 101 points compared to previous day premium of 111 points.


BankNifty closed at 33585 on a positive note with 0.93% increase in open interest indicating Long Build Up.

BankNifty Futures closed at a premium of 267 points compared to the previous day premium of 304 points.

FII's were **Buyers** in **Index Futures** to the tune of **1880** crores and were **Sellers** in **Index Options** to the tune of **559** crores, **Buyers** in the Stock Futures to the tune of **718 crores**. **Net Buyers** in derivative segment to the tune of **1681 c**rores.

India VIX index is at 20.65 v/s 22.70.Nifty ATM call option IV is currently 19.15 whereas Nifty ATM put option IV is quoting at 19.73





Index options PCR is at 1.14 v/s 1.13 & F&O Total PCR is at 0.93.

Among stock futures Long Build up are APLLTD, IDEA, SAIL & LALPATHLAB may remain strong in coming session.

Stock which witnessed Short Build up are **POWERGRID**, **LUPIN**, **PFIZER** & **BATAINDIA** may remain weak in coming session.

Nifty Put options OI distribution shows that 14000 has highest OI concentration followed by 14500 & 14700 which may act as support for current expiry.

Nifty Call strike 15000 followed by 14500 witnessed significant OI concentration and may act as resistance for current expiry.
