Comments

Nifty weekly contract has highest OI at 15200 for Calls and 14000 for Puts with highest new OI addition at 15000 and 14500 respectively.. In Nifty March monthly contract, highest OI is at OTM 16000 for Calls and at ATM 14500 for Puts, with highest new OI addition at 16000 and 14200 respectively. FIIs increased their futures long position by 2.79% and cut shorts by 1.12%. In options, FIIs cut their position by 41.14% in Call longs, 48.71% in Call shorts, 16.03% in Put longs and 21.71% in Put shorts.
