



## **HIGHLIGHTS:**

Nifty futures closed at 14984.65 on a positive note with -0.75% decrease in open interest indicating Short Covering.

Nifty Futures closed at a premium of 42 points compared to previous day premium of 46 points.


Bank Nifty futures closed at 33302.65 on a positive note with 5.16% increase in open interest indicating Long Build Up.

Bank Nifty Futures closed at a premium of 160 points compared to previous day premium of 134 points.

FII's were **Seller** in Index Futures to the tune of **-322** and were **Buyer** in Index Options to the tune of **2622 crores**, while they were net **Seller** in Stock Futures amounting to **-1674 crores**. FII's were net **Buyers** in derivative segment to the tune of **694 crores**.

India VIX index is at 20.23 v/s 20.82.Nifty ATM call option IV is currently 18.65 whereas Nifty ATM put option IV is quoting at 20.11

Index options PCR is at 1.33 v/s 1.33 & F&O Total PCR is at 1.01.

Among stock futures **ALKEM**, **TORNTPOWER**, **VOLTAS & BEL** have witnessed long build up and may show strength in coming session.

Stock which witnessed short build up are **PNB**, **COFORGE**, **GUJGASLTD & LTI** and may remain weak in coming session.

Nifty Call strike 15000 followed by 15500 witnessed significant OI concentration and may act as resistance for current expiry.

Nifty Put options OI distribution shows that 14000 has highest OI concentration followed by 14500 & 14600 which may act as support for current expiry.
