



HIGHLIGHTS:

Nifty futures closed at 15144.85 on a positive note with -2.60% decrease in open interest indicating Short Covering.

Nifty Futures closed at a premium of 37 points compared to previous day premium of 29 points.


Bank Nifty futures closed at 34045.2 on a positive note with -5.23% decrease in open interest indicating Short Covering.

Bank Nifty Futures closed at a premium of 123 points compared to previous day premium of 90 points.

FII's were **Buyer** in Index Futures to the tune of **3,076** and were **Buyer** in Index Options to the tune of **5,961 crores**, while they were net **Seller** in Stock Futures amounting to **-957 crores**. FII's were net **Buyers** in derivative segment to the tune of **8,254 crores**

India VIX index is at 19.24 v/s 19.61. Nifty ATM call option IV is currently 17.61 whereas Nifty ATM put option IV is quoting at 16.89

Index options PCR is at 1.39 v/s 1.40 & F&O Total PCR is at 1.03.

Among stock futures **MINDTREE**, **ASHOKLEY**, **LTI & MPHASIS** have witnessed long build up and may show strength in coming session.

Stock which witnessed short build up are **BHARTIARTL**, **GODREJCP**, **ALKEM & ITC** and may remain weak in coming session.

Nifty Put options OI distribution shows that 14500 has highest OI concentration followed by 14800 & 14700 which may act as support for current expiry.

Nifty Call strike 15200 followed by 15500 witnessed significant OI concentration and may act as resistance for current expiry.
