



### HIGHLIGHTS:

Nifty futures closed at 15218 on a positive note with 19.00% decrease in open interest indicating Short Covering.

Nifty Futures closed at a premium of 15 points compared to previous day discount of 26 points.

BankNifty closed at 34758 on a negative note with 9.20 % decrease in open interest indicating Long Unwinding

BankNifty Futures closed at a premium of 42 points compared to the previous day discount of 012 points.

FII's were **Buyers** in **Index Futures** to the tune of **1477** crores and were **Buyers** in **Index Options** to the tune of **2186** crores, **Sellers** in the Stock Futures to the tune of **1960 crores**. **Net Buyers** in derivative segment to the tune of 1350 crores.

India VIX index is at 19.13 v/s 19.05.Nifty ATM call option IV is currently 14.89 whereas Nifty ATM put option IV is quoting at 18.02

Index options PCR is at 1.22 v/s 1.30 & F&O Total PCR is at 0.98.

Among stock futures Long Build up are **UBL ONGC, TVSMOTOR & IGL** may remain strong in coming session.

Stock which witnessed Short Build up are AMARAJBAT, SAIL, NATIONALUM & HDFCLIFE may remain weak in coming session.

Nifty Put options OI distribution shows that 15000 has highest OI concentration followed by 14500 & 152X00 which may act as support for current expiry.

Nifty Call strike 15500 followed by 15300 witnessed significant OI concentration and may act as resistance for current expiry.
