Precious metals

Gold prices edged up on Monday, hovering near their highest in more than four months, as a weaker dollar and pullback in U.S. Treasury yields supported the safe-haven metal.

NYMEX Oil

Oil prices rose on Monday as a storm formed in the Gulf of Mexico and Iran said a three-month nuclear monitoring deal had expired, raising doubts about the future of indirect talks that could end U.S. sanctions on Iranian crude exports. Brent crude oil futures for July rose 32 cents, or 0.5%, to \$66.76 a barrel by 0143 GMT, while U.S. West Texas Intermediate for July was at \$63.93 a barrel, up 35 cents, or 0.6%.

Base Metals

Chile's state-run Codelco, the world's largest copper producer, said in a letter to lawmakers this week that as much as 40% of its copper output is at risk if a bill that limits mine operations near glaciers advances, according to a report in local daily El Mercurio.

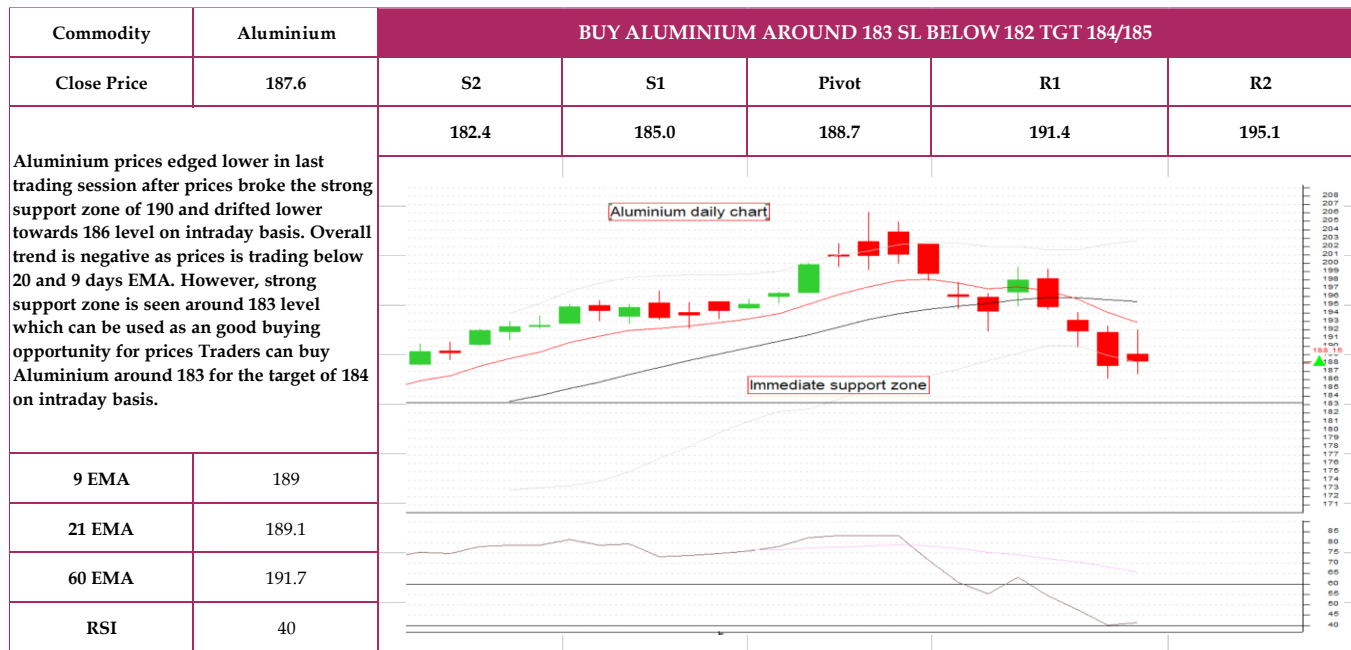
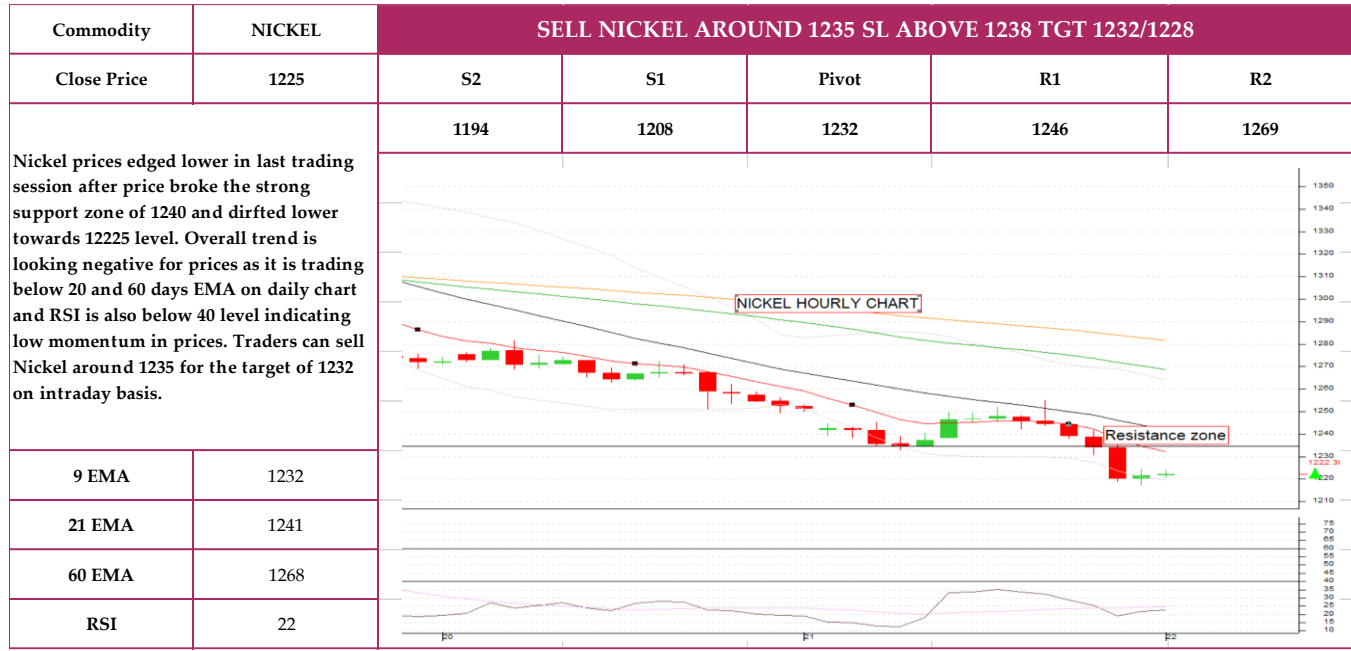
