- ➤ Short term trend of the stock is positive where it is trading above its 5 and 20 and 50 day EMA.
- Oscillators like RSI and MFI is showing strength in the stock.
- > Plus DI is trading above Minus DI, Indicating strength in the current uptrend.
- ➤ Considering the Technical evidences discussed above, we recommend buying the Phillips Carbon between 217.2-218 and average at 202, for the upside targets of 243 and 265, keeping a stop-loss at 195.
