- Matter showing consolidation in the last few weeks, the stock price (Jyothy Lab) has witnessed a sustainable upside bounce in this week and is trading at the highs.
- >>> The stock price is currently forming a triangle type pattern and is advancing towards the upper end of a triangle at Rs 160 levels.
- As per this pattern, one may expect a decisive upside breakout of a triangle in the near term, which could open more upside for the stock price ahead.
- >>> Weekly 14 period RSI shows positive indication and volume has started to rise during upmove in the stock price.
- >>> The overall chart pattern of JYOTHYLAB indicate long trading opportunity. One may look to create positional long as per the levels mentioned above.
