



HIGHLIGHTS:

Nifty futures closed at 14691 on a negative note with 6.08% increase in open interest indicating Short Build Up.

Nifty Futures closed at a premium of 60 points compared to previous day premium of 37 points.

BankNifty closed at 32894 on a negative note with 4.21 % decrease in open interest indicating Long Unwinding.

BankNifty Futures closed at a premium of 112 points compared to the previous day premium of 93 points.

FII's were **Sellers** in **Index Futures** to the tune of **2963** crores and were **Buyers** in **Index Options** to the tune of **4861** crores, **Buyers** in the Stock Futures to the tune of **661 crores**. **Net Buyers** in derivative segment to the tune of **2037** crores.

India VIX index is at 23.03 v/s 23.31.Nifty ATM call option IV is currently 20.33 whereas Nifty ATM put option IV is quoting at 25.05

Index options PCR is at 1.07 v/s 1.43 & F&O Total PCR is at 0.93.

Among stock futures Long Build up are **SAIL**, **NAVINFLUR**, **ONGC** & **HINDPETRO** may remain strong in coming session.

Stock which witnessed Short Build up are **ESCORTS, TCS**, **HEROMOTOCO** & **BIOCON may** remain weak in coming session.

Nifty Put options OI distribution shows that 14000 has highest OI concentration followed by 14500 & 13800 which may act as support for current expiry.

Nifty Call strike 15000 followed by 15500 witnessed significant OI concentration and may act as resistance for current expiry.
