Comments

Nifty weekly contract has highest open interest at 16000 for Calls and at 15300 for Puts while monthly contract has highest OI at 16000 for Calls and 14000 for Puts. Highest new OI addition was seen at 16000 for Calls and 15400 for Puts in weekly and at 16000 for Calls and 15000 for Puts in monthly contracts. FIIs increased their futures long position by 6.70% and their futures short position by 20.36%. FIIs increased their position in index options by 25.90% in Call longs, 54.39% in Call shorts, 27.69% in Put longs and 44.62% in Put shorts.
