



HIGHLIGHTS:

Nifty futures closed at 16621 on a positive note with 3.21% increase in the open interest indicating Long Build Up.

Nifty Futures closed at a discount of 7 points compared to the previous day discount of 15 points.


BankNifty closed at 35698 on positive note with 2.39% increase in open interest indicating Long Build Up.

BankNifty Futures closed at a premium of 85 points compared to the previous day premium of 35 points.

FII's were **Sellers** in **Index Futures** to the tune of **1350** crores and were **Sellers** in **Index Options** to the tune of **1511** crores, **Buyers** in the Stock Futures to the tune of **613 crores**. **Net Sellers** in the derivative segment to the tune of 2298 crores.

India VIX index is at 20.32 v/s 20.84. Nifty ATM call option IV is currently 19.92 whereas Nifty ATM Put option IV is quoting at 23.10





Index options PCR is at 1.20 v/s 0.82 & F&O Total PCR is at 0.9

Nifty Put options OI distribution shows that 16300 has highest OI concentration followed by 16500 & 16400 which may act as support for current expiry.

Nifty Call strike 17000 followed by 16700 witnessed significant OI concentration and may act as resistance for current expiry.

BankNifty Put options OI distribution shows that 35500 has highest OI concentration followed 36000 which may act as support for current expiry.

BankNifty Call strike 36000 followed by 36200 witnessed significant OI concentration and may act as resistance for current expiry.
